Chairman's Report!

The Trust's Board met recently for a two day meeting which incorporated the Annual General Meeting of the Trust. At the ordinary meeting, each District Trustee reports on their district. This enables the pooling of ideas that can be used by all trustees. The Finance and Investment Committee reports on the state of the Trust's investments and the Treasurer reports on the financial position of the Trust. There are three other committees, namely the Administration, Promotion and Grants and Loans Committees. Our Legal Counsel also reports on any legal matters that need to be brought to the attention of the Board. The Past International Director and the Council Chairman bring to the Board matters that might have an impact on the Trust's activities.

At the Annual General Meeting, the annual accounts of the Trust are presented. The balance date of the Trust is 30 June and the accounts to 30 June 2020 show that Trust had a surplus of \$131,000 compared to a surplus in 2019 of \$255,000. This drop can be attributed to lowering interest rates, something we are all familiar with, and also a decline in Club contributions attributable to Covid 19 which prevented clubs from meeting.

The Annual Accounts are subject to audit and this will commence on the 7th September. Once completed, the accounts will be available on our website and also at the Charities Commission website.

Honour Roll

The Honour Roll is available on this website and also displayed at District and Multiple District Conventions. The roll is open to all those who have been Lions, Lionesses or members of their families. The Roll of Honour perpetuates the memory of those who gave so much of themselves to their Club and the welfare of others. When requested a framed certificate is presented.



Grants and Loans

The process of applying for a grant or loan is that the District Trustee needs to provide an application form to the Club who, having completed the form, returns it to the District Trustee. The District Trustee will review the application and may well ask for further information before indicating their agreement to the application. Once agreed to it is then forwarded to the Grants and Loans Committee for consideration and acceptance or otherwise. Last year (2020) we made grants of \$167,000 and a loan for \$30,000. Loans are appropriate where the activity to be financed is a fundraising activity which will generate income to repay the loan.
